

City of Walnut Grove **Business License Affidavit**

Sec. 26-35. - Display of license.

It shall be the duty of any person conducting a licensed business in the city to keep his/her license posted in a conspicuous place on the premises used for such business at all times.

Sec. 26-36. - Inspections.

- (a) Search of premises. Whenever inspections are a reasonable precedent to the licensing of a business or to the detection of violations of public peace, order, or morality that would normally be cause to revoke a license for any period of time, it shall be the duty of the licensee, or the person in charge of the premises to be inspected, to admit thereto, for the purpose of making the inspection, any officer or employee of the city who is authorized or directed to make such inspection at any reasonable time that admission is requested.
- (b) *Testing of material*. Whenever an analysis of any commodity or material is a reasonable precedent to the licensing of a business or to the detection of violations of the public welfare that would normally be cause to revoke a license for any period of time, it shall be the duty of the licensee of the municipality whose business is governed by such provision to give to any authorized officer or employee of the city requesting the same, sufficient samples of such material or commodity for such analysis.
- (c) Refusal to allow inspection. In addition to any other penalty which may be provided, the mayor may revoke the license of any licensed proprietor of a licensed business in the city who refuses to permit any officer or employee who is authorized to make such inspection or take such sample to make the inspection, or take an adequate sample of the said commodity, or who interferes with such officer or employee while in the performance of his/her duty in making such inspection; provided that no license shall be revoked for such cause unless written demand is made upon the licensee or person in charge of the premises, in the name of the city, stating that such inspection or sample is desired at the time it is sought to make the inspection or obtain the sample.

Contact Information Required

Each business shall provide emergency contact information, including: Business owner or license holder's contact information and current on-site manager or shift leader's contact information.

Brick and Mortar Establishments

It is the intent of the City of Walnut Grove to grant licenses only to active business entities. An active entity may be determined through posted hours (and adherence to posted hours), no evidence of vacancy, or through business transactions.

A business that remains inactive for more than 30 days will be notified of revocation of the entity's business license. Before any revocation occurs, the city will hear any appeal on or after 15 days notice to the business entity at a regularly scheduled council meeting.

Food and Food Establishment

Before a business license is issued or renewed to any food establishment in the city, written approval from the county department of public health shall be on file with the city, stating that the premises have been inspected and that the establishment meets the requirements of the state food laws. Any such license shall be revoked upon the recommendation of said department of public health if a nuisance or health hazard is created or exists. A recommendation to revoke such license shall not be made, however, until the establishment has failed or refused to comply, within a reasonable time, with the rules and regulations applicable.

No person shall engage in handling food or food products, in any form or container, for distribution in the city, without a permit from the state.


