Alan Barton reported the work on the building behind City Hall is done except painting. The tractor was delivered last Thursday. It has already been used to clear dirt from the roadway near Cambridge. The sidewalks in town were edged. On the north side of Hwy 138 toward Monroe there is not much sidewalk just dirt and grass. Alan Barton reported work will begin on City Hall which will include painting and some woodwork. He purchased the supplies for the Old City Hall. Sheriff Joe Chapman provided trustees to do the work. The oxidation pond is ¾ dug.

The drilling is being done on the force main. Next they will lay the pipe. Alan Barton brought up an issue with a tree hanging over the road on Park St. Lt 490 is where the tree is. We have to get this taken care of. Wayne Dimsdale said he had talked to the owner and he says he will not do anything about the tree. Wayne Dimsdale said Brett Davis needs to issue a citation. The tree is a Water Oak 8" to 10" in diameter. Alan Barton says he cannot take the limb down without risking injury due to the position of the limb. Alan Barton reported everything else is good. He is waiting to see what the Church on the Parkway is going to do. He will let the crabgrass take over the roundabout and maybe water will be run down the parkway to the Church.

Wayne Dimsdale made a motion the financials be approved, Kathy Dimsdale seconded the motion. All were in favor. Motion carried. Wayne Dimsdale asked if Walnut Grove was going to get a new Fire Department. The Mayor advised there will be a Fire Department built on Hwy 81.

Request for Bill Board Permit by George Wells

Joe Reitman recommended we contact Mr. Wells and have him come in and reapply for a sign permit for a sign 150 square feet in size. If he meets the size criteria the Mayor can approve it without having a hearing. The criteria involved with a Bill Board were discussed by the council members which involved the distance to the closest sign and he would have to be in a commercial district. Joe Reitman said he would not be able to put up a billboard but can scale
