- Motion: Council Member Maxine McClanahan motioned to approve Resolution 2025-04 which extends the moratorium on the accepting of applications for rezoning or building permits for properties located in the downtown overlay district.

2. Vote: Public Comment Amendment - Ordinance 2025-02

Council Member Rachel Davis motioned to approve **Ordinance 2025-02**, an ordinance amending **Ordinance 2024-01** regarding parliamentary procedure and procedures of meetings. The amendment aims to promote orderly public engagement, repeal conflicting ordinances, and address other matters.

The approval is **conditional** upon the following changes:

- In the **Public Comment** section, remove the final sentence: "Public comment will be allotted no more than thirty minutes or when each citizen who wishes to speak has spoken, whichever is sooner." Add the option for individuals who notify 48 hours in advance to the City Clerk, initial speaking privileges at the start of public comment.
- In the **Town Hall** section, remove the final sentence: "Town Hall will be allotted no more than thirty minutes or when each citizen who wishes to speak has spoken, whichever is sooner." And remove the sentence: "Any individual wishing to speak must submit their, name, address, and topic of discussion to the city clerk forty-eight hours in advance."
- Second: Mayor Pro Tem Erica Miles
- Motion carried unanimously

3. Vote: City Hall Exterior Painting and Repair Project
