Yard waste collection is included in the base rate (3 brown bags) and an optional chargeable service for additional yard waste beyond the allotted limit.

**10. Section VII.E page 11: who bills the extra yard waste, extra bulk services?**

The city will bill the extra yard waste, extra bulk services.

**11. Section VII.I page 12- will ALL residents receive a new 95-gal cart for trash collection?**

All residents will receive a 95-gal cart in good repair and appearance.

**12. Section VII.I page 12- will residents have the choice for 18gal or 65gal individually? Or will the city choose one size for ALL residents?**

Residents will have an 18gal collection bin as a part of the base rate. Residents may individually choose to upgrade to a 65gal cart for an additional charge.

**13. Section VII.I page 12- referring to the "hot stamp" for carts. Since this will increase the cart cost, will the city consider other options for cart branding?**

The city will consider alternative options for cart branding.

**14. Section VIII.E page 14- is the back door cap 5% or 10%? Both numbers are stated here.**

The back door cap is set at 5%.

**15. Section VIII.B page 13 states that bulk collection is (1) time per week "for an additional fee", but the fee schedule in Section IX. Indicates that (1) bulk item per week is part of the base rate.**

Bulk pickup is not part of the base rate and must be scheduled for an additional charge.

**16. Are alternative proposals to requested service levels and frequency permissible?**

Alternative proposals are welcome for commercial solid waste services, however, residential must meet the service levels and frequency outlined in the RFP.

**17. Will the amounts for required insurance in the RFP be adjusted at a lower amount in order to give the city a price that would reflect an average compared to other municipalities?**
